ABOUT THIS GRANT

To generate understanding of contemporary art practice among students, Punjab Lalit Kala Akademi will provide travel grant to students of Visual Art and Visual Art History who are currently enrolled in BFA/MFA/BA with Fine arts, MA with Fine Arts and MPhil in Fine Arts in any college, art institution and university of Punjab, and those with Punjab domicile studying in any of the above disciplines in any college, art institution and university in Chandigarh to travel and witness the creatively charged environment and ambience of mega art events organised in various parts of the country such as India Art Fair, New Delhi.

THE GRANT INCLUDES

- Return travel from the student's place of study to the venue of India Art Fair, New Delhi.
- A modest room for stay on twin sharing basis or dormitory depending upon the availability.
- Daily allowance for food and beverages.
- The orientation of the selected applicants at the premises of Punjab Lalit Kala Akademi few days before the students depart for the specified Art Venue.
- Maximum of Rs 6,000/- for India Art Fair, New Delhi which includes travel, stay, food and local expenses, shall be paid by the Akademi.

ELIGIBILITY CRITERIA

- Applicants are eligible to apply if (all conditions below are met):
- Applicant is a domicile of Punjab.
- Or Applicant is currently studying (as regular student) in BFA/MFA/BA with Fine arts, MA with Fine Arts, MPhil in Fine Arts in any college, art institution and university of Punjab and Chandigarh.
- Applicant's age on 25.01.2023 should be between 18 to 30 years.

RULES AND REGULATIONS:

- a. The Akademi takes no responsibility of the behaviour, actions and conduct of the selected applicant throughout the duration of the travel grant including travel and stay at the venue and the orientation period.
- b. The Akademi takes no responsibility for any mishap or accident during the travel period and stay at the venue and the orientation period. It is the responsibility of the student to get the health and travel insurance done, if she/he so desires. Akademi will be responsible only for providing financial assistance to the student.
- c. The Akademi will try to get the return tickets reserved for the selected students but if the Akademi is unable to do so then the selected students will have to do the reservations on their own. Applicant may have to find his/her own place to stay in case Akademi is unable to make the bookings for which the applicants shall be notified in advance.
- d. A report of 500-750 words along with images of venue and the student at the venue is to be submitted within 15 days of the completion of travel grant period.
- e. The selected applicants will be given preference in the future programmes of the Akademi, as the grant is also meant for the grooming of budding artists in the state.
- f. Akademi shall pay/reimburse up to Rs 6,000/- for India Art Fair, New Delhi including travel, stay, food and local expenses.
- g. Only those students can apply who are enrolled in regular courses. Students of correspondence studies are not eligible to apply for this grant.
